WHY CALL US

REASONS to call Carolinas Poison Center

- 1. You'll receive care from experts. Our healthcare providers are Specialists in Poison Information. We have special knowledge about how substances act in the body, which toxins are more concerning than others, and what to do if something shouldn't have been tasted, touched or breathed. Board-certified medical toxicologists back up the specialists.
- 2. It may save a trip to the emergency department or urgent care. Nearly 75 percent of our calls are handled at home or at the call site.
- **3. We can provide immediate help.** Sometimes people call in a panic. We can accurately and quickly address your concern and let you know if the issue will require the next level of care.
- 4. Calls are free and confidential. Often callers are concerned that their calls will be "reported" to a social service agency. Well-meaning callers never need to worry! We keep your information private the same way your doctor's office does.
- **5. We don't judge.** We know accidents happen. We're here to help. Each year our staff is ranked exceptionally by our callers who say the specialists at the poison center really listened to their concern. If you've ever had to call, you've likely experienced the care and compassion firsthand.

Anything can be a poison if it's used in the wrong way, wrong amount or by the wrong person.







WHAT WAS THE **AGE** OF THE PERSON **EXPOSED** TO THE POISON?




HELPING Healthcare Providers

Did you know that 20% of our call volume comes from other healthcare providers? IT'S TRUE!

Nurses, pharmacists and doctors rely on Carolinas Poison Center to answer questions and provide treatment advice about things like overdoses, new kinds of drug abuse or bites from venomous creatures. That's because the people who answer the phones are nurses and pharmacists who are specially trained to field questions about poisonings. Board-certified toxicologists are available to answer more complicated questions when needed.

WHO PLACED THE CALL?





Here are a few examples of calls we receive:

- A child who's given an extra dose of medicine by a parent or caregiver
- Someone who's come in contact with poison ivy on a camping trip
- A healthcare provider with questions about a patient who has taken synthetic drugs
- A toddler who has swallowed a pill that was found on the floor
- A doctor who is treating a patient for a snakebite
- A senior adult who has accidentally taken the wrong diabetes medicine

The Carolinas Poison Center takes over 250 calls every day. The nurses, pharmacists, and doctors who handle the calls at the center are just a phone call away. Most calls can be handled at the site of the call, saving you the cost of seeking additional care.

SPOTLIGHT ON POISONS: Laundry Pods

In 2012, Carolinas Poison Center identified a new trend when we received reports of young children who had been harmed after being exposed to laundry detergent pods. If the product ended up in a young child's hands, the pods could burst in the mouth, on the skin, or near the eye and could cause serious medical complications. Symptoms included excessive vomiting, extreme tiredness or even trouble breathing.

In 2012 and 2013, Carolinas Poison Center took 482 calls about laundry detergent pods. As a result of the increase in calls to poison centers nationwide about these products, some manufacturers began reevaluating the way that laundry pods were packaged. In 2013 additional safety packaging was added to some product containers. Carolinas Poison Center continues to monitor and provide treatment advice for laundry detergent pod exposures across the state.

SPOTLIGHT ON POISONS: Rx Drugs

Exposures to both over-the-counter and prescription drugs are a primary reason people call the poison center. One out of every five calls concerns some kind of pain reliever. Calls to the poison center in North Carolina are reflective of the growing use of prescription pain medicine use nationwide.

Furthermore, opioid analgesic pain reliever use has increased over 300 percent in a decade's time. Opioid analgesics provide pain relief by working with the central nervous system to block the feeling of pain. Some common opioid analgesics include hydrocodone, oxycodone and methadone. The death rates for poisoning related to opioid analgesics more than tripled from 2000 to 2010 according to the CDC.

Carolinas Poison Center can help callers who have questions about taking their medicines safely. We can also provide medical advice in the event medicine has been taken incorrectly or by the wrong person. 1 in 4 high school seniors had taken a prescription medicine not intended for them.

SHARING PILLS CAN KILL CAMPAIGN

In 2012, after monitoring trends in prescription drug misuse and abuse, the Carolinas Poison Center began an education campaign targeting teens. Through market research, the poison center discovered that middle and high school students did not often understand that sharing their medicines could be harmful. We also learned that one in four high school seniors had taken a prescription medicine not intended for them. The poison center laid the groundwork to launch the "Sharing Pills Can Kill" campaign. The message aimed to help teens think about only taking medicines as prescribed.


The campaign has been used in local school districts, injury prevention coalitions, addiction facilities, pediatric clinics, behavioral health facilities and other agencies serving adolescents and their families. To date, the Sharing Pills Can Kill Public Service Announcement has had over 700,000 impressions and has been promoted across the state in both print and online venues.






TIPS that can help keep POTENTIAL POISONS OUT OF CHILDREN'S HANDS:


- 1) Keep household cleaners and medicines up and away and locked if possible.
- 2) Don't call medicine "candy."
- 3) Talk to children about the safe use of household products and medicines.
- 4) Store all products in their original containers.
- 5) Take the product or medicine with you to answer the door or the phone.



Monitoring Poisonings ACROSS THE STATE


Because we take calls from all 100 counties in North Carolina, the poison center can easily track trends and outbreaks. We can alert public health officials and first responders to outbreaks concerning things like food borne illnesses and chemical or biological agents.

We upload data in real-time to the North Carolina Disease Event Tracking and Epidemic Collection Tool (NCDETECT) to provide state epidemiologists a comprehensive picture of poisonings throughout North Carolina. We also upload data to the National Poison Data System (NPDS), a database that collects poison center data from around the country to aid in nationwide surveillance.


